# Sea-Doo Days 2025 Game - BRP FULL REGULATIONS

# **Article 1: Organizing company**

BRP France, a company with share capital of €100,000, whose registered office is located at Route de la Côte d'Azur, 13 590 MEYREUIL, France, registered under RCS Aix-en-Provence B 482 596 533 (hereinafter referred to as the "Organizing Company") is organizing a Game with no obligation to purchase from 09/05/2025 to 25/05/2025 [23:59] (day inclusive).

#### **Article 2: Participants and eligibility**

This no-obligation game is open exclusively to adults residing in mainland France (including Corsica and Monaco), Germany or Austria, the Netherlands, Belgium, Luxembourg, Italy, Spain and the United Kingdom.

Persons who do not meet the above conditions are excluded from the Contest, as are members of the Organizing Company's staff and any person directly or indirectly involved in the design, production or management of the Contest, as well as their spouses and family members: direct ascendants and descendants or other relatives, whether or not living under their roof.

The Contest is limited to one entry and one prize per person (same surname, same first name, same postal address, same e-mail address) or per company name (same name/company name, same address, same e-mail address) for the entire duration of the Contest.

The Organizing Company reserves the right to ask any participant to provide proof of the above conditions. Any person who does not meet these conditions or who refuses to provide proof will be excluded from the Contest and, in the event of winning, will not be entitled to his/her prize.

Participation in the Contest implies full acceptance of these rules.

# **Article 3: Terms and conditions of participation**

**STEP 1:** Visit your nearest dealership between 09/05/2025 and 25/05/2025 and **scan** the QR code present in the dealership.

#### STEP 2: REGISTER online no later than 25/05/2025 [23:59

- Enter your personal details (surname, first name, postal address, email address, telephone number)
- Select your point of sale
- SUBMIT your entry and find out immediately if you have won a prize

Any winnings must be collected immediately from the dealership.

Once you have taken part, you will automatically be entered into the prize draw which will take place on 16/06/2025 for a chance to win one of the 14 Sea-Doo Stand-Up PADDLES up for grabs.

Any participation made contrary to the provisions of these Rules shall render the participation invalid. Any participant suspected of fraud may be excluded from the Contest by "Organizing Company" without having to justify itself. # Article 4: Designation of winners and prizes up for grabs

#### 4.1: By instant win

The prizes at stake are:

- 925 Caps with a unit value of 33€ / 35£ / 353kr including VAT

The winners will be designated by a system of open instant-win prizes randomly distributed throughout the duration of the Operation. Each instant-win period corresponds to a single prize.
